Subject: Employment Services Transformation – Toronto and Northern Catchments

Dear Employment Ontario partners:

The government is taking the next step in the integration of the province's employment services system. Today, I am pleased to announce the launch of the competitive selection process for Service System Managers (SSMs) across the final Phase 3 catchment areas of Toronto, Northeast, and Northwest.

Since February 2019 the Ministry of Labour, Immigration, Training and Skills Development (MLITSD) has worked to transform Ontario's employment services by integrating Employment Ontario with Ontario Works Employment Assistance and Ontario Disability Support Program Employment Supports together to improve client outcomes. The new system has been implemented in 12 catchment areas across Ontario where SSMs now oversee the design and delivery of employment services in their communities.

Phase 3 Competitive Process

As with the previous phases, the ministry will be using a two-stage competitive process to select new SSMs for the Northeast, Northwest and Toronto catchment areas. This process

begins with a Request for Qualification (RFQ) to identify organizations that are interested and best qualified to fulfil the role of SSM. The RFQ document is available on the <u>Ontario Tenders</u> <u>Portal</u> under reference Tender #18140 until June 2, 2023. Qualified applicants will be invited to participate in the Call for Proposals stage in the summer/fall.

I would like to highlight that the RFQ has been informed by the Employment Services
Transformation market sounding and vendor engagement sessions. These sessions allowed
the ministry to gather feedback on how to improve service delivery and client outcomes in the
complex catchment areas of Toronto, Northeast, and Northwest. The ministry also continues to
consult with SSMs, stakeholders and partners on improvements to the Integrated Employment
Services model.

Next Steps

Additional details about the RFQ stage of the competitive process will be provided through information sessions in May. Details about these information sessions are available in the RFQ document on the Ontario Tenders Portal. I remain committed to providing regular updates to our service providers and stakeholders as the ministry continues to move through the Phase 3 competitive process.
