Subject: CFP RELEASE - 2024 Ontario Bridge Training Program (OBTP)

I am pleased to inform you that the Ministry of Labour, Immigration, Training and Skills Development (MLITSD) has released a Call for Proposals for the Ontario Bridge Training Program (OBTP) for delivery of occupation-specific training, employment supports and licensure preparation to support the successful labour market integration of internationally trained newcomers.

The deadline for submission of applications is at 5:00pm EST on December 12th, 2024.

The 2024 OBTP Call for Proposals includes program design changes designed to reach more clients, improve performance, and expand programming in high-demand occupations in support of skilled newcomers, employers, and regulated professions.

Key features of the 2024 CFP include:

- Successful projects for the upcoming funding cycle will begin on April 1, 2025, and be funded for up to two years (2025-26 and 2026-27).
- Focus on high-demand sectors to align with Ontario's labour market needs and immigration policy priorities.
- Mandatory program components include stronger focus on partnerships with employers and regulated professions and provision of occupation-specific

training and assistance to clients to navigate registration processes in regulated professions and compulsory trades.

- Expansion of client eligibility criteria to include Provincial Nominees and temporary residents with a clear pathway to permanent residency.
- Changes to educational and language requirements to align with industry standards and diverse requirements for registration established by regulated professions.
- Integration of OBPAP into OBTP Transfer Payment Agreements to align funding cycles with program timelines and reduce administrative burdens.

Applicants can apply for more than one funding opportunity to deliver programming under one or both direct service streams:

- Getting a Job Projects that deliver occupation-specific training and employment supports to help internationally trained newcomers obtain commensurate employment in regulated occupations or non-regulated occupations.
- Getting a License Projects that deliver training and employment supports to help internationally trained newcomers obtain licensure or certification to practice in regulated occupations and find commensurate employment in their field of training.
